

## Michael Ancram, Lord Lothian

Former Member of Parliament, United Kingdom



Michael was born in 1945, educated at Oxford and Edinburgh Universities. He is married, with two daughters.

He is a Scottish QC having practiced largely at the criminal bar between 1970 and 1979.

He was first elected to Parliament in 1974. His ministerial career involved four years as the political minister in Northern Ireland responsible for the early initial political engagements with the IRA and the beginnings of the Peace Process which led eventually to the Good Friday Agreement. He was the first British Minister to meet the IRA for 25 years.

Subsequently he was Chairman of the Conservative Party for three years. He stood unsuccessfully for the Conservative Party Leadership in 2001. He was then for four years Shadow Foreign Secretary and Deputy Leader of both the Conservative Party and HM Opposition. In 2005 he stood down from the front bench to concentrate on setting up and chairing an International Affairs and Security think tank (Global Strategy Forum) and a Gulf liaison forum. He continues his hands-on interest in conflict resolution through regular direct talks with islamist movements in the Middle East.

From 2006-2010 and from 2011 he has been and is a member of the UK Intelligence and Security Committee which oversees UK Intelligence Agencies.
