## Honorary Chairman of the Presidium of the non-governmental Council on Foreign and Defense Policy



Born September 12, 1952.

Graduated in 1974 from the Department of Economics of the Moscow State University.

1989 — 2010 — Founder and Deputy Director of the Institute of Europe of the Academy of Sciences of USSR/Russia.

Since 2006 - Dean of the School of International Economics and Foreign Affairs of the National Research University Higher School of Economics (NRU HSE).

### Research activities

Specialization: Soviet/Russian foreign and defense policies, security and economic aspects of Russian-European interaction.

Author and editor of 28 books and brochures, published around 500 articles on economics of foreign policy, arms control, national security strategy, Russian foreign and defense policies. Articles and books were published in more than 40 countries.

2006 - 2010 — Member of the Public Council Under the Minister of Defense of the Russian Federation.
