A Saudi expert on Gulf politics and strategic issues, Dr. Abdulaziz Sager is the founder and Chairman of the Gulf Research Center, a global think tank based in Jeddah with a well-established worldwide network of partners and offices in both the Gulf region and Europe.

In this capacity, Dr. Sager has authored and edited numerous publications including *Combating Violence & Terrorism in the Kingdom of Saudi Arabia*, *The GCC's Political & Economic Strategy towards Post-War Iraq and Reforms in Saudi Arabia: Challenges and Feasible Solutions*. He is also a frequent contributor to major international media channels and appears regularly on Al-Arabiya Television, France 24 and the BBC. In addition to his academic activities, Dr. Sager is actively engaged in track-two and mediation meeting. For example, he has chaired and moderated the Syrian opposition meetings in Riyadh in December 2015 and November 2017.

In addition to his work with the Gulf Research Center, Dr. Sager is President of Sager Group Holding in the Kingdom of Saudi Arabia, which is active in the fields of information technology, aviation services and investments. Furthermore, he holds numerous other appointments including on the Makkah Province Council, Advisory Board of the Arab Thought Foundation, Geneva Centre for the Democratic Control of Armed Forces, Faculty of Economics and Administration at King Abdulaziz University, Saudi Ministry of Education, Geneva Center for Security Policy and German Orient Foundation. Dr. Sager has also sat on the advisory group for the UNDP Arab Human Development Report, and participates in the Think Tank Leaders Forum of the World Economic Forum and the Council of Councils of the Council on Foreign Relations.

Dr. Sager holds a Ph.D in Politics and International Relations from Lancaster University and an M.A. from the University of Kent, United Kingdom and a Bachelor Degree from the Faculty of Economics and Administration of King Abdulaziz University.

Gulf Research Center

Established in 2000 by Dr. Abdulaziz Sager, the Gulf Research Center (GRC) is an independent think tank dedicated to the study of the Gulf region with a focus on the region's political, security, economic, energy and social developments. GRC engages in analysis and debate in an effort to promote an in-depth understanding of the countries of the Gulf Cooperation Council (GCC) and its neighbors and foster cooperation and security.

As a non-for-profit organization, GRC injects all the income it generates back into its research programs and activities. In this way, it is able to preserve and maintain its independence and continuity.

One of GRC's main activities is the study of social science in a Gulf region context. As a result, GRC has identified more than 50 areas of critical research that are necessary to address the current information deficit. Examples of the GRC research programs include GCC Foreign Relations, GCC Defense and Security Issues, GCC Economic Issues, GCC Social Issues, Gulf Energy Program and Science and Technology in the Gulf.

Each program aims to cover a specific issue in as much detail as possible. In many cases, the Center has identified bilateral relations which may not have been fully addressed. This presents the Center and its extensive community of contributors with the significant challenge of shedding light on unexplored relationships between the GCC states and the world at large.

While the Center is particularly concerned with the international relations and politics of the GCC states, its research interests also include domestic and regional issues which affect the political, economic, security and societal life of the GCC member states and those of Iran, Iraq and Yemen.

As part of its research agenda, the GRC seeks to conduct objective and scholarly research as it relates to the GCC states in particular and the geopolitical region of the Gulf in general; secure a better future by promoting communication and cooperation among GCC citizens and disseminating information about the GCC states and the Gulf region through a series of events; publish and distribute relevant and useful information and data on the GCC states within and outside the region; interact with and answer the knowledge requirements of individuals and organizations interested in Gulf region developments, including academics, researchers, university students, the press, businessmen and decision-makers; facilitate dialogue among scholars specialized in Gulf affairs, both within and outside the region; provide education and training solutions through implementing a 'knowledge program' targeting higher management circles in the fields of politics, economics, security and business; as well as monitor and aggregate news coverage of events and developments in the Gulf region as published and broadcast by local, regional and international media, making this available for research purposes. On December 9 and 10, 2015, Dr. Sager chaired and moderated a conference entitled "Extended Meeting of the Syrian Opposition Factions" (called the Syrian Opposition meeting) held in Riyadh which resulted in the Syrian opposition nominating a team for the negotiations in Geneva.

Key achievements

In 2015 Global Go-to Think Tank Report, the Gulf Research Center is ranked among the key think tanks in the Middle East and North Africa region, as one of the leading 150 think tanks in the world, and a leading think tank in the areas of foreign policy and international affairs. The GRC has consistently maintained a leading position since the first Global 'Go-To Think Tanks' survey was released in January 18, 2012.

The GRC is a member of the Economic and Social Council of the United Nations (ECOSOC), accredited to the Governing Council of the United Nations Environmental Program (UNEP); is accredited to the Global Environment Facility (GEF) of the World Bank; has served as a Knowledge Partner of the World Economic Forum. The GRC is also a member of the Council of Councils and the Think Tank Leader's Forum.

Active Membership

In November 2003, Dr. Sager was appointed as a member of the Makkah Province Council. In addition, he serves as a member on the advisory board of the Arab Thought Foundation; the Geneva Centre for the Democratic Control of Armed Forces (DCAF); the Faculty of Economics and Administration of King Abdulaziz University; the Ministry of Higher Education, Saudi Arabia; the Geneva Centre for Security Policy (GCSP); the German Orient Foundation; and sits on the advisory group for the 4th Arab Human Development Report for the United Nations Development Programme (UNDP). In May 2011, Dr. Sager was awarded an honorary fellowship from the Università Ca'Foscari in Venice, Italy. Dr. Sager is also holding a position as a Guest Professor at Osaka University, Japan. Dr. Sager is also an Active Member of the Board of Trustees for Koing Abdulaziz Center for National Dialogue.
