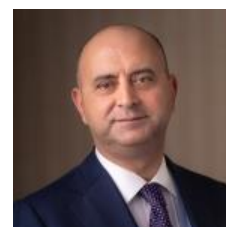

➤ 2019	-GSP signs with OMV Petrom the Integrated Services Contract, consolidating its position in the Black Sea and entering into a new core area of business

GSP Training Centre is equipped with Drill SIM 6000, incorporating the latest drilling and well control cyber-chair training technologies
➤ 2008	-Upetrom Group registers more than EUR 400 million turnover -GSP enters the offshore construction market with a 100 million USD contract awarded by TPAO, Turkey -GSP is awarded by EMSA (European Maritime Safety Agency) the contract for the oil pollution response capability in the Black Sea along the European Union border
