

Message du fondateur et président de la WPC



Thierry de Montbrial

Fondateur et président de la WPC L'année écoulée depuis la onzième édition de la WPC a été marquée par le durcissement de la concurrence entre les États-Unis et la Chine. Les deux puissances impériales visent, l'une, à préserver la position hégémonique dont elle bénéficie depuis 1945; et l'autre, à l'occuper. L'Europe est l'un des principaux théâtres d'opération dans ce duel. Les États-Unis ne souhaitent pas qu'elle acquière les moyens de son autonomie, et n'ont pas intérêt à ce qu'elle s'ouvre trop à la Chine. Celle-ci, de son côté, a intérêt à la diviser pour affaiblir les institutions euro-atlantiques, et à y multiplier les investissements afin de s'y implanter. À cet égard, les Chinois se comportent comme ailleurs, en Afrique notamment.

Un des aspects majeurs de la situation est la véritable guerre économique entre les deux superpuissances pour la domination des technologies numériques et pour l'acquisition des données (data). À l'heure actuelle, l'hypothèse la plus probable est que l'on va vers une sorte de duopole, avec deux systèmes technologiques, et la question se posera de leurs interfaces avec les autres régions du monde, notamment en Europe. À la limite, la perspective d'une nouvelle partition du monde en blocs, une possibilité qu'à la surprise de certains j'ai déjà évoquée à la WPC, ne saurait être complètement écartée.

À court-moyen terme, la scène est dominée par des rivalités classiques, comme au Moyen-Orient ou en Corée, en même temps que par la guerre commerciale et la révision des conceptions occidentales du rôle des investissements directs, en particulier en Europe. On n'hésite plus à parler de la nécessaire protection des industries nationales face à l'asymétrie des relations avec la Chine. Parallèlement, la croissance économique chinoise rencontre des difficultés internes que les autorités du pays compensent par un surcroît autoritaire et une certaine exaltation nationaliste. Le bras de fer qui se joue actuellement à Hong Kong pose la question de l'avenir du principe « un pays, deux systèmes » dont l'enjeu principal, à très haut risque, est évidemment Taïwan. Le nationalisme n'est pas propre à la Chine. L'Inde, par exemple, n'est pas en reste sous le règne de Narendra Modi. Sans parler du Brésil et de bien d'autres régions ou pays.

D'une manière générale, la transformation du système international suscite des reclassements géopolitiques et géoéconomiques partout sur la planète, liés à la montée de la Chine mais aussi à l'unilatéralisme américain, latent depuis la fin de la guerre froide et exacerbé depuis l'avènement de Donald Trump.

Il y va notamment de l'avenir de l'Afrique et de ses relations avec l'Europe. Ces deux grandes régions sont liées par la densité de leurs interdépendances géostratégiques, conséquences de la géographie et de l'histoire.

Comme les précédentes, cette douzième édition de la WPC visera à mieux comprendre les enjeux et les tendances à court, moyen ou long terme, et à dégager des conduites stratégiques, principalement quoique non exclusivement du point de vue des puissances moyennes, et toujours dans l'esprit de préserver un monde raisonnablement ouvert, alors que les menaces ne manquent pas.

Message from the founder and chairman of the WPC

The year since the eleventh edition of the WPC has seen sharper competition between the United States and China. The two imperial powers aim, one, to preserve the hegemonic position from which it has benefited since 1945, the other, to occupy it. Europe is a key theatre of operations in this rivalry. The United States does not wish Europe to acquire the means of its autonomy, and it is not in their interests for it to open up to China too much. Meanwhile, China has an interest in dividing Europe in order to weaken the Euro-Atlantic institutions, and in increasing investment in order to establish itself there. In this regard, the Chinese are behaving as they do elsewhere, particularly in Africa.

One of the situation's major aspects is the real economic war between the two superpowers to dominate digital technology and acquire data. At the moment, the most likely hypothesis is that we are heading towards a kind of duopoly, two technological systems, and the question will arise of interfaces in different regions of the rest of the world, particularly Europe. Ultimately, the prospect of the world splitting into blocks, a possibility that to the surprise of some I have already mentioned at the WPC, cannot be completely ruled out.

In the short to medium term, the scene is dominated by classic rivalries, such as in the Middle East or Korea, as well as by trade war and the revision of Western conceptions of the role of direct investments, especially in Europe. We no longer hesitate to talk about the need to protect national industries in the face of asymmetrical relations with China. At the same time, China's economic growth is heading into troubled waters that the country's authorities are compensating for with an authoritarian bent and an exaltation of nationalism. The current strife in Hong Kong raises questions about the future of the principle of "one country, two systems", the main, and very risky, challenge of which is obviously Taiwan. China does not have a monopoly on nationalism. India, for example, is not to be outdone under Narendra Modi, not to mention Brazil and many other regions or countries.

By and large, the transformation of the international system has led to a global geopolitical and geoeconomic shift linked to the rise of China and American unilateralism, latent since the end of the Cold War and exacerbated since Donald Trump's election.

The future of Africa and its relations with Europe are at stake. These two major regions are linked by the density of their geostrategic interdependencies, the consequences of geography and history.

As in previous years, the twelfth WPC will aim to better understand the issues and short, medium or long-term trends and identify strategic behaviours, mainly although not only from the medium powers' viewpoint and always in the spirit of preserving a reasonably open world at a time when there is no lack of threats.

SESSION PLÉNIÈRE 1

Perspectives économiques et politiques dans le contexte de la montée de la Chine

Lors de la 11e édition de la WPC, on pouvait penser que les perspectives économiques mondiales étaient favorables, sous réserve de chocs politiques. Depuis lors, ceux-ci se sont multipliés, principalement du fait de l'aggravation de la guerre commerciale entre les Etats-Unis et la Chine. Sans négliger d'autres chocs, comme les incertitudes politiques du Brexit ou celles autour de l'Iran. Sur un plan plus strictement économique, on s'interroge sur la solidité de la croissance chinoise, ou encore indienne. L'objectif de cette session est de dresser un panorama aussi objectif que possible des perspectives économiques mondiales. On se demandera aussi si l'augmentation du nombre et de l'ampleur des chocs politiques est une tendance lourde, susceptible de remettre la mondialisation en question.

La pérennité de la mondialisation – la position chinoise

L'histoire des dernières années a révélé l'attachement de la Chine à la mondialisation, dont elle a en effet considérablement bénéficié depuis son entrée à l'OMC en 2001. Mais il est apparu également de plus en plus clairement que Pékin voulait une modification des institutions de la gouvernance globale tenant davantage compte de l'évolution des rapports de force. De leur côté, les Occidentaux, les Américains mais maintenant aussi les Européens, dénoncent ouvertement les avantages asymétriques dont la Chine bénéficie à leurs yeux. L'objet de cette session est de présenter le point de vue chinois sur ces auestions.

PLENARY SESSION 1

World political economic outlook in the context of the rise of China

At the 11th edition of the WPC, it would have been reasonable to expect a bright global economic outlook, subject to political storms. Since then, their number has been on the rise, mainly due to the worsening trade war between the United States and China, but also the political uncertainty surrounding Brexit or Iran. On a more strictly economic level, the strength of China or India's growth is something to wonder about. This session aims to provide as objective an overview as possible of the global economic outlook. It will also ask whether the rise in the number and magnitude of political shocks is a major underlying trend that could pose a challenge to globalization.

PLENARY SESSION 2

Sustaining globalization – the Chinese position

The history of the past few years shows China's commitment to globalization, which has benefited that country considerably since it joined the WTO in 2001. But it has also become increasingly clear that Beijing seeks changes in the institutions of global governance that take shifting power relations into account more. For their part, the West, the Americans but now also the Europeans, openly criticise what they see as China's asymmetrical advantage. This session aims to present China's view on these issues.

SESSION PLÉNIÈRE 3

Conversation avec Jean-Paul Agon, PDG de l'Oréal, et Thierry Bolloré, directeur général de Renault

Commerce, investissement direct et Confiance

La politique étrangère des Etats-Unis, depuis l'élection de Donald Trump, est fondée dans tous les domaines sur le retour au bilatéralisme, qui favorise en effet à court terme la loi du plus fort. Or, sur le moyen et long terme, l'économie internationale ne peut prospérer durablement que dans le respect de règles du jeu et dans un climat de confiance. L'objectif de cette session est de prendre la mesure de l'ampleur du climat de défiance qui prévaut actuellement et de ses conséquences notamment dans le domaine de l'investissement direct. On attendra également des panélistes leurs analyses sur la possibilité de renverser les tendances actuelles.

SESSION PLÉNIÈRE 5

La politisation du système international des paiements et l'avenir du système monétaire international

Depuis la Seconde Guerre mondiale, le dollar n'a cessé de renforcer sa position par rapport aux autres monnaies, au point qu'il occupe aujourd'hui sans conteste une position hégémonique. Cette position a été acceptée par les partenaires des Etats-Unis dans la mesure où le recours au dollar facilite grandement les échanges économiques de toute nature dans un système international de plus en plus intégré. Une conséquence indirecte de cette situation est que tous les opérateurs de la planète sont soumis à un moment ou à un autre à la loi américaine. Or, la dénonciation unilatérale par les Etats-Unis du traité de 2016 avec l'Iran (JCPOA) et la décision du président des Etats-Unis de punir les opérateurs internationaux qui ne respecteraient pas les sanctions imposées également unilatéralement à l'Iran, a suscité des réactions vigoureuses un peu partout dans le monde. C'est en effet la souveraineté des Etats qui se trouve ainsi mise en cause. L'objectif de cette session est d'évaluer l'importance de la question ainsi soulevée et d'examiner la possibilité que d'autres grandes monnaies, comme l'euro ou le renminbi, ne cherchent à s'émanciper en devenant monnaie de réserve.

PLENARY SESSION 4 Trade, direct investment and Trust

Since Donald Trump's election, US foreign policy has been based in every area on a return to bilateralism, which in the short term favours the law of the strongest. However, in the medium and long term, the international economy can only prosper sustainably if the rules of the game are followed in a climate of trust. This session aims to assess the extent of the current climate of mistrust and its consequences, particularly in the area of direct investment. Panellists will also be expected to provide their analyses on the possibility of reversing current trends.

PLENARY SESSION 5

The politicization of the international system of payments and the future of the international monetary system

Since the Second World War, the dollar has steadily strengthened its position against other currencies to the point where it now undoubtedly occupies a hegemonic position. The United States' partners have accepted this position because using the dollar greatly facilitates economic exchanges of all kinds in an increasingly integrated international system. An indirect consequence of this situation is that all the world's players are at one time or another subject to US law. However, the unilateral pull-out by the United States from the 2016 treaty with Iran (JCPOA) and President Trump's decision to punish international players who do not comply with the sanctions unilaterally imposed on that country have caused strong reactions around the world. The sovereignty of States is being called into question. This session aims to assess the issue's importance and examine the possibility that other major currencies, such as the euro or the renminbi, may seek to emancipate themselves by becoming reserve currencies.

session plénière 6 L'arme du droit et la mondialisation

À tort ou à raison. l'application extraterritoriale des lois américaines est souvent considérée par les autres nations, notamment en Europe, comme une illustration de l'impérialisme juridique et un instrument de guerre économique. Pourtant, dans une économie mondialisée, on ne saurait s'étonner que l'application extraterritoriale des lois nationales et internationales tende à devenir la norme. Trois évolutions récentes changent toutefois la donne de manière troublante : l'attention croissance des autorités chargées de la mise en œuvre sur la responsabilité individuelle et celle des employeurs, l'avènement d'acteurs non démocratiques comme acteurs clés de l'économie internationale, et l'état toujours plus conflictuel de l'économie et de la politique mondiales. Comme l'illustrent plusieurs exemples récents, la conjonction de ces tendances structurelles génère ce qu'on pourrait qualifier de géopolitisation préoccupante de la loi, qui voit les dirigeants devenir otages de la géopolitique, des conflits de souverainetés nationales, des conflits interentreprises et de l'unilatéralisme, sans pour autant être protégés par les garanties internationales traditionnelles de l'état de droit, Que faire pour contrer cette nouvelle menace insidieuse qui pèse sur la mondialisation et un ordre international fondé sur l'état de droit?

The weaponization of Law and globalization

Rightly or wrongly, the extraterritorial application of U.S.laws has often been viewed by other nations, particularly in Europe, as a manifestation of legal imperialism and as an instrument of economic warfare. Yet, in a globalized economy, one should not be surprised that the extraterritorial application of national and international laws tends to become the norm. Three recent developments, however, are changing the game in a troublesome way: the growing focus of enforcement authorities on individual executive liability along with that of their corporate employers, the rise of non democratic powers as key players in the international economy, and the increasingly conflictual state of the world economy and politics. As illustrated in several recent instances, the conjunction of these structural trends results in what one may call a worrisome geopoliticization of law, where executives can become hostage to geopolitics, clashes of national sovereignties, corporate conflicts, and unilateralism, without the protection of traditional international guarantees of the rule of law. What can be done to counter this new, insidious threat to globalization and a rule of law-based international order?

session plénière 7 Technologie, société et politique

Partout, les pouvoirs publics et les systèmes politiques qui leur confèrent autorité et légitimité sont dépassés par les changements technologiques qui se produisent sur le plan digital presque partout dans le monde, simultanément. Les places de marché sont tout aussi bousculées, de même que les schémas d'emploi, les systèmes commerciaux et les relations humaines. Baptiser ce changement la Quatrième révolution industrielle, c'est sous-estimer son envergure et sa force de frappe. Les robots, les voitures autonomes, les réseaux et médias sociaux par satellite qui interfèrent déjà dans les élections des démocraties les plus puissantes de la planète, l'intelligence artificielle et les algorithmes qui permettent l'impression 3D et la fabrication localisée, sont les sianes avant-coureurs d'un monde transformé et radicalement nouveau. La praticité et l'efficience permises par la technologie moderne doivent être mesurées à l'aune de son coût en matière de cohésion sociale et de confiance. Les suppressions d'emplois dans les principaux secteurs industriels génèrent colère et insécurité, de même que les déplacements croissants d'un nombre considérable de migrants, menacés par les guerres, le changement climatique et la répression. Ces réactions émotionnelles sont amplifiées par une révolution de la communication qui permet aux opposants populistes et aux autocrates établis de contourner les partis politiques traditionnels et les médias traditionnels pour mobiliser ou contrôler les réactions populaires. Les États-Unis, par exemple, semblent abandonner les traditions qui renforcent le désir des pères fondateurs d'une république représentative plutôt qu'une démocratie

PLENARY SESSION 7

Technology, society and politics

Governments everywhere—and the political systems that give them authority and legitimacy—are being overwhelmed by technological change that today arrives digitally in nearly all corners of the globe simultaneously. Also shaken are market places, employment patterns, trading systems, and human relations. To call this change the Fourth Industrial Revolution is to understate its scope and force. Robots, driverless automobiles, satellite-delivered social media networks that have already intervened in elections in the world's most powerful democracies, artificial intelligence and algorithms that enable threedimensional printing and localized manufacturing, are all harbingers of a world transformed and disrupted. The convenience and efficiency that modern technology offers society have to be weighed against the costs in social cohesion and trust that have also accompanied this change. Job losses in key industrial sectors in many countries produce anger and insecurity, as does the growing displacement across borders of huge numbers of migrants threatened by modern warfare, climate change and repression. These emotional responses are magnified by a communications revolution that allows both outsider populist forces and entrenched autocrats to bypass traditional political parties and the established media to mobilize or control popular response. The United States, for example, seems to be abandoning traditions that reinforce the Founding Fathers' desire to have a representative republic rather than a direct democracy. Other countries will soon be faced with their own debates over the virtues and vices of plebiscite by Twitter. The trends toward a

Tous les Etats ont aujourd'hui pris conscience de l'importance des cyber-menaces de toute nature. Encore faut-il analyser avec précision la notion de cyber-puissance dans le monde d'aujourd'hui. Chacun pense aux Etats-Unis ou à la Chine, mais d'autres pays de poids économique moindre ont également développé des cyber-capacités plus ou moins significatives, comme la Russie, la Grande-Bretagne, la France ou encore Israël. L'objectif de cette session est d'abord d'éclairer concrètement cette notion de cyber-puissance, mais aussi les différentes menaces dont il s'agit, comme le hacking, les fake news et de plus en plus les deep fake news etc. Une vraie cyber-puissance doit-elle posséder à la fois des capacités offensives et défensives ? Peut-on parler d'une pensée stratégique dans ce domaine?

Quel est l'état actuel des soins en Afrique ? Quels sont les régions et secteurs qui réussissent, et pourquoi? Quels sont sinon certains des défis régionaux spécifiques, que ce soit en Afrique orientale, en Éthiopie, en Afrique du Sud ou en Afrique occidentale? Nous savons que la santé sert de bloc fondateur d'une vie meilleure. Elle ouvre des portes, par exemple en autorisant un enfant à aller à l'école ou un parent à conserver un emploi. PLENARY SESSION 8

Cyber powers and the cyber threat

All States have by now become aware of the importance of cyber threats of every kind. But a precise analysis of the notion of cyber-power in today's world is still necessary. Everyone thinks of the United States or China, but other countries of lesser economic weight, such as Russia, Great Britain, France and Israel, have also developed more or less significant cyber-capacities. The goal of this session is to shed light on the notion of cyber-power in concrete terms and the various threats involved, such as hacking, fake news and, increasingly, deep fake news. Should a real cyber-power have both offensive and defensive capabilities? Is strategic thinking an appropriate term to use in this context?

It's important to make sure that technological uses and advancements are practical and serve people without creating undue burdens or cost. How can companies, governments and NGOs work together to weigh cost-benefit analysis and ensure the best outcomes? We can't overlook the importance of properly fusing Western medicine and methods with African culture and customs. That applies to everything from standard child care to preventing the spread of communicable diseases. What lessons are being learned today in this regard and how can medical and public health professionals do better?

PLENARY SESSION 11 European uncertainties

The European Union is still going through a thorny patch due to economic troubles that have not yet been fully resolved, the lack of coherent immigration or refugee policies and the endless ordeal of Brexit. It also suffers from poor governance. Some of its citizens seem tempted by illiberal democracy and it is hard to identify common ground on the goal of European integration across the Union. Between the United States, which is turning towards Asia and no longer seems invested in the belief in a shared destiny with Europe, and China, which is taking advantage of the EU's weaknesses to penetrate it better, what are the chances that the Union will rethink its project and become a significant international player in the coming decades?

PLENARY SESSION 12 Where is Latin America heading?

Outside observers of Latin America may have the impression that the cycles of the past are doomed to repeat themselves. Are they right? The two situations that have attracted the most attention from the "international community" in recent months are the failure to resolve the crisis in Venezuela and the victory of the populist Jair Bolsonaro in Brazil. A goal of this session is to better understand the developments in these two countries and their impact on the international system as a whole. The trade agreement between Mercosur and the European Union could also be discussed.

PLENARY SESSION 13

Middle East and North/West Africa

Whether in Europe or Africa in the broad sense, political and economic developments in the Middle East and North Africa are of major geopolitical importance. Eight years after the "Arab Spring", the situation in the Middle East has not yet stabilized. And although the Islamic State has lost its territorial conquests, it remains terribly active. The terrorist threat has not decreased in the Sahel in West Africa, on the contrary. Tunisia is still not stabilized, and Algeria's future is currently in the balance. This session seeks to better understand this region's challenges and its main stakeholders' policies.

PLENARY SESSION 14

Cross-border illegal trade: a destabilizing factor for the global economy

Illegal trade becomes an important issue for the world economy. With an average growth of 20% annually and a total amount valued at more than 700 billions dollars, it places an heavy burden on a number of countries at industry and field of taxation level. Focused on a dozen of activities, using all digital-content resources, it is in the hands of international criminal groups and benefit from the weaknesses of some states. What are the logistics and sales networks of material and immaterial products targeted by traffickers? How consumers react in front

PLENARY SESSION 16 Young Leaders

According to the Intergovernmental Panel on Climate Change (IPCC), scientific evidence for warming of the climate system is unequivocal and the responsibility lies with the abundant and cheap fossil fuel upon which we have built our prosperity for the last two-hundred years. Notwithstanding the natural resistance from carbon-rich fuel producers, some western countries' politicians are calling for Green New Deals, with the aim of achieving net-zero greenhouse gas emissions, creating millions high-wage jobs, and investing in sustainable industry and infrastructure through a combination of regulations and subsidies.

The private sector, as a significant contributor to greenhouse gas emissions, is to take its rightful part in this collective effort and recent technology disruptions such as artificial intelligence (AI) or the Internet of Things (IoT) could be a response to the climate crisis. What is the respective role of the state, the private sector and the citizens in addressing the climate crisis? How to ensure environmental measures are fair. both internally and amona nations? Which solution between a carbon tax and a green new deal presents the most promising outcome? Which of the following is the most effective level to act: local, regional. national, international? What are the technology drivers that can contribute to this effort? Is deceleration

PLENARY SESSION 17 New foreign policy trends in East Asia

The foreign policy of major States is based on permanent data. This is the case for the centuries-old relations between China and Japan, or between China and India. But these policies also evolve as circumstances change. Thus, the rise of China is forcing all the States in the region to adapt. Their strategic mobility must be all the greater as the world's second-largest power is increasingly openly nationalistic while at the same time its economy seems to be heading into troubled waters. The establishment of direct relations between the US and North Korean presidents has also opened up new opportunities. Not to mention the Hong Kong crisis and so on. Should we consider that the enormous economic forces at work in the wider Indo-Chinese world will remain the dominant factor in the comina years, or is there a serious risk of major geopolitical upheavals or even wars with incalculable consequences? How can Taiwan's future be envisaged in this context?

ATELIER 1

Finance et économie

I. Croissance mondiale

Pour la plupart des observateurs et institutions financières internationales, la croissance mondiale reste en berne. Une grande part de cette économie mondiale décevante est imputable aux conflits commerciaux entre les États-Unis et la Chine, et par conséquent à la baisse considérable du taux de croissance des échanges internationaux et de la confiance, facteurs aggravés par plusieurs événements adverses éventuels, notamment un Brexit sans accord et la concrétisation possible de risques géostratégiques (Iran, Corée du Nord, etc.). En tenant compte de tous les éléments, le consensus actuel table sur une croissance mondiale d'environ 3,2 % en 2019, en très forte chute par rapport à 2018 (3,6 %). Ce ralentissement semble toucher autant les économies avancées (1,9 % en 2019 contre 2,2 % un an auparavant) que les économies émergentes (4,1 % en 2019 contre 4.5 % un an auparavant). Les projections actuelles prévoient une croissance mondiale en 2020 proche de celle de 2019, ou légèrement plus élevée, sous réserve que les nombreux risques défavorables qui se profilent ne se concrétisent pas. Dans les économies avancées, le niveau d'inflation reste très bas dans quasi tous les pays, ce qui entraîne des politiques persistantes d'accommodation monétaire anormalement élevées pour rétablir un fonctionnement plus normal de l'économie, y compris le ciblage de l'inflation et des taux d'intérêt nominal élevé. Cette situation n'est pas sans risque car la marge de manœuvre des politiques monétaires, en cas de difficultés économiques majeures ou de récession, est extrêmement limitée tandis que dans nombre de pays - mais pas tous - l'espace fiscal est lui aussi relativement restreint (Japon, États-Unis, Royaume-Uni, plusieurs pays européens). Les causes sous-jacentes de ces maladies des économies avancées sont nombreuses - mondialisation, technologie, progrès médiocres de la productivité, affaiblissement de la puissance de néaociation des salariés... Les risaues qui pèsent sur le scénario de base risquent principalement d'être revus à la baisse. D'éventuelles tensions commerciales supplémentaires pourraient ralentir encore plus les investissements mondiaux et entraîner une diminution de l'appétence pour le risque partout dans le monde. Une augmentation de l'aversion pour le risque pourrait exposer les vulnérabilités intégrées à la finance mondiale après des années de politiques monétaires extrêmement accommodantes. Pour la confiance des agents économiques internationaux, l'imprévisibilité de l'administration américaine est particulièrement facteur d'inquiétude.

WORKSHOP 1

Finance and economy

I. Global growth

Global growth remains subdued in the eyes of most observers and of the International Financial Institutions. A large part of this disappointing global economy is due to the trade dispute between the US and China, the ensuing significant decrease of the rate of growth of global trade and confidence empowered by a number of adverse possible events, including a no deal Brexit and the possible materialization of geostrategic risks (Iran, North Korea...). All taking into account, the consensus looks at present for a global growth around 3,2% in 2019, a significant reduction in comparison with 2018 (3.6%). This slowing down seems to be equally shared between advanced economies (1,9% in 2019 from 2,2% a year before) and the emerging economies (4,1% in 2019 from 4,5% a year before). Present projections would call for a global growth in 2020 which would be close to growth in 2019 or a little bit higher provided there is no materialization of the many downside risks that are looming. In the advanced economies, the level of inflation is still very low in almost all countries triggering persistent abnormal highly accommodating monetary policies to reestablish a more normal functioning of the economy, including inflation on target and higher nominal interest rates. This situation is dangerous because the room for maneuvering for monetary policy, in case of major economic difficulties or recession, is extremely limited while in many countries - but not all - the fiscal space is itself quite limited (Japan, USA, UK, several European countries). The underlying causes of this advanced economies diseases are numerous - globalization, technology, mediocre productivity progress, weakening of the bargaining power of labor... Risks to the baseline scenario are mainly to the downside. Further possible trade tensions could slow global investment even more and trigger weaker risk appetite all over the world. An increase in risk aversion could expose the vulnerabilities embedded in global finance after years of extremely accommodating monetary policies. Particularly alarming for global economic agents confidence is the unpredictability of the future moves of the new US administration.

Possible questions to be addressed

- Are we in agreement with the present projections of global growth for 2019 and 2020?

II. Risques financiers internationaux

Le G20 a pris des mesures et des décisions remarquables au niveau mondial après la crise financière mondiale de 2007-2008-2009 (GFC). Tout d'abord, en précisant que de nouvelles règles financières, réglementations, principes de précautions, normes et codes devaient être décidés au niveau mondial afin de s'assurer que tous les déclencheurs possibles d'une nouvelle crise financière mondiale seraient identifiés où qu'ils se trouvent dans l'économie mondiale intégrée. Deuxièmement, en garantissant des conditions de concurrence équitables dans la finance mondiale, à la fois comme concept équitable dans une économie mondiale intégrée et comme moyen approprié d'éviter des phénomènes d'arbitrage réglementaire dangereux. Troisièmement, en soutenant un réseau de comités organisés autour de la Banque des règlements internationaux (BIS) et du Conseil de stabilité financière (FSB) pour tirer les leçons de la GFC, et en cherchant un consensus mondial en vue de généraliser les nouveaux principes de précaution, normes et codes mondiaux qui contribueraient à prévenir une nouvelle crise financière systémique dramatique. Aujourd'hui, 11 ans après la faillite de Lehman Brothers, où en sommes-nous?

- d/ Abrupt episode of financial risk aversion,
- e/ US recession,
- f/ European recession.

II. Global financial risks

The G20 took remarkable actions and decisions at a global level after the GFC (Great Financial Crisis) of 2007-2008-2009. First, by making clear that new financial rules, regulations, prudentials, standards and codes had to be decided upon at a global level in order to be sure that all possible triggers for a new alobal financial crisis would be identified wherever they would be located in the integrated global economy. Second, by ensuring that there will be a level playing field in alobal finance, both as a fair concept in an integrated global economy and as the appropriate mean to avoid dangerous regulatory arbitrage. Third, by backing the network of committees organized around the BIS and the Financial Stability Board (FSB) to draw the lessons from the GFC, and by looking for a global consensus with a view to generalize the new global prudentials, standards and codes that would help prevent a new dramatic systemic financial crisis. Now 11 years after the bankruptcy of Lehman Brothers, where do we stand today?

1. The positives

Amongst the many positives, I would stress particularly: a/Significant improvements were made on the banks prudentials. The package finalizing the Basel III banking reforms is marking the completion of an extremely important endeavor. b/The "derisking" in correspondent banking relationship has been important. c/The generalization of the central clearing of OTC derivatives to reduce systemic risk is also a substantial improvement. d/The first work done on cybersecurity.

1. Les points positifs

Parmi les nombreux points positifs, je voudrais souligner les suivants en particulier : a/Des mesures d'envergure ont été prises pour les règles prudentielles. L'ensemble de mesures qui finalise les réformes bancaires de Bâle III marque la fin d'un effort extrêmement important. b/Le « de-risking » dans la relation de correspondant bancaire est également très important. c/La généralisation de la compensation centrale des dérivés de gré à gré pour réduire le risque systémique est tout aussi importante. d/Le premier travail fait sur la cybersécurité.

2. Le dur labeur qu'il reste à faire et qui présente des risques

Parmi les nombreux domaines où il reste encore du travail, je soulignerai en particulier les éléments suivants:

- a/ La dimension actuelle du système bancaire parallèle et du système non bancaire est essentielle en termes d'instabilité financière mondiale potentielle. L'activité financière non bancaire progresse rapidement selon l'Institut de la finance internationale (IIF) (environ 184 trillions de dollars, soit près de la moitié de tous les actifs financiers). Même sans les banques, les sociétés d'assurance et les fonds de pension, les « autres partenaires financiers » représenteraient environ 117 trillions de dollars, soit 30 % du total.
- b/ Le problème des mauvaises conduites reste à résoudre entièrement. Le FSB a réalisé un travail important dans ce domaine au cours des dernières années, y compris la mise au point de sa future boîte à outils pour les entreprises et les superviseurs sur l'utilisation de cadres de gestion pour atténuer le risque de mauvaise conduite. Mais beaucoup reste à faire.

2. The hard work which remains to be done and present risks

Amongst the many fields where work remains to be done, I will particularly stress the following:

- a/ The present dimension of shadow banking and non-bank is of the essence in terms of potential global financial instability. Non-bank financial activity is rising rapidly according to the IIF, representing around 184T\$, namely close to 50% of total financial assets. Even without banks, insurance companies and pension funds the "other financial intermediaries" would represent around 117T\$, namely 30% of the total.
- b/ The issue of misconduct is still to be fully tackled. The FSB has done significant work in this domain over the last years, including its future toolkit for firms and supervisors on the use of governance frameworks to mitigate misconduct risk. But a lot of work remains to be done.
- c/ The financial risks associated with crypto-assets are also an open issue. It is true that the combined market value of such assets represents around 1% of global GDP. But the market continues to evolve rapidly and is morphing from cryptocurrencies to an explosion of new "crypto-tokens". More active work must continue to be done by the international community in disciplining this domain where complacency would be a big mistake.
- d/ The many pockets of bubbles and financial instability (in all economies, including emerging) associated with a long period of very accommodating monetary policies in all advanced economies.

Possible questions to be addressed

 Is the international community sufficiently aware of the new emerging properties of global finance that are potentially destabilizing (combination of new

Énergie et environnement

Près de quatre ans après la signature de l'accord de Paris sur le climat, le monde est loin d'avoir débuté la transition énergétique nécessaire pour s'aligner sur une trajectoire à 2°C, et encore plus loin d'une trajectoire à 1,5°C, préférable au premier scénario. La défiance à l'égard d'une gouvernance climatique mondiale se renforce (États-Unis, Brésil, Arabie saoudite, notamment), les émissions de aaz à effet de serre continuent d'augmenter, de même que la demande énergétique sous la pression de la croissance démographique, de la croissance économique et des secteurs de la construction et du transport. Véritable cri d'alarme, le rapport d'octobre 2018 du GIEC n'a pas suffi à initier les changements nécessaires. L'Union européenne est en passe d'adopter l'objectif d'une neutralité carbone d'ici à 2050 et ambitionne d'ouvrir la voie en la matière tout en se dotant d'outils pour que d'autres avancent dans la même direction. Le prix européen du carbone (CTS) atteint déjà près de 30 euros/tonne. À l'international, le coût des déploiements renouvelables ne cesse de baisser et les niveaux d'investissement sont solides même s'ils restent très en-deçà de la trajectoire de Paris et largement absents en Afrique. Le déploiement du charbon reste positif, mais ralentit. Le secteur du transport entame une décarbonisation au long cours. Le secteur bancaire se prépare progressivement à mettre en place des instruments destinés à accélérer la transition énergétique bas carbone. Dans le monde occidental, l'économie circulaire, les obligations écologiques, la responsabilité sociale des entreprises, les empreintes carbone et l'efficience énergétique deviennent de plus en plus les nouveaux moteurs décisionnels des parties prenantes publiques et privées.

Le monde est à un tournant de son histoire et le temps presse pour mettre en place mesures et politiques adaptées. Il n'existe pas de technologie ni de solution magique: l'avenir repose sur une combinaison des différentes technologies (solaire, éolien, nucléaire, batteries, hydrogène, gaz de synthèse ou écologiques, CCUS, efficience énergétique), des politiques coordonnées et des cadres réglementaires et d'investissement incitatifs. La tarification et la réglementation en matière de carbone seront les principaux facteurs de changement et la réussite repose sur une transition équitable au niveau local, national et international. WORKSHOP 2

Energy and environment

Almost four years after the signature of the Paris agreement on climate, the world is far from having started the needed energy transition and aligning with a 2°C trajectory, and even less with the preferable 1.5°C trajectory. Defiance for the global climate governance becomes stronger (USA, Brazil, Saudi Arabia notably), greenhouse gas emissions continue to rise, so is energy demand, driven by population growth, economic growth and the transport & construction sectors. The October 2018 IPCC report was an alarm call yet did not entice the required changes. Nor did major changes come from the dramatic threats facing biodiversity which have been scientifically assessed.

All is not bleak though. Leading companies and cities take actions to fully decarbonize. Insurance companies are raising pressure to align corporate strategies with the climate reality. So are shareholders. The EU is close to adopting a carbon neutrality objective by 2050 and aims to showcase global leadership and have instruments to make others move in the same direction. The European carbon price (ETS) has almost reached 30 EUR/tonne. Globally, renewable deployment costs keep falling and investment levels are robust yet way below the Paris trajectory and largely absent in Africa. Coal deployment is still positive, but slowing down. The transport sector has started a long haul decarbonisation. The banking sector is progressively preparing to lay out instruments to accelerate the low carbon energy transition. Circular economy, green bonds, corporate social responsibility, carbon footprints and energy efficiency are increasingly the new drivers of private and public stakeholders' decisions in the Western world

The world is at a turning point as the clock is ticking to put the right policies and measures in place. There is no magic technology or solution but a combination of technologies (solar, wind, nuclear, batteries, hydrogen, blue and green gases, CCUS, energy efficiency), coordinated policies and conducive investment & regulatory frameworks. Carbon pricing and regulation will be key drivers of changes and a fair transition at local, national and global levels is a condition for success. But also changes in consumer behaviour and recycling of goods. While a lot of focus is on the energy sector and CO2 emissions, decarbonizing the industry and agriculture sector, and reducing methane emissions, will be crucial as well. So will be efforts to fund and organize adaptation measures. And this at a time of mounting global uncertainties over multilateralism, trade and security.

The Climate Action Summit in New York on 23 September 2019 and COP 25 in December 2019 will offer a crucial momentum to reinforce national contributions.

This workshop will discuss the way ahead, four years after the Paris Agreement: what are the short and

Africa

The fall of the Berlin Wall in 1989 and the disappearance of the East-West blocs seemed to allow Africa, long considered a mere pawn in the clashing goals and interests of foreign powers, to assert itself more strongly in international affairs on the political, economic and cultural fronts.

Africa is positioning itself as a continent of the future. It has set up many "strategic partnerships" based on its potential. Its growth indicators have markedly improved over the past decade, but its role in the global economy has not fundamentally changed: supplying raw materials and markets for products manufactured outside the continent, where industrialization remains weak. Intra-continental trade has barely increased.

More broadly, Africa still has scant influence on the rule-making processes aiming to shape a fairer international order that can meet its expectations and the considerable challenges of the times.

Keenly aware of the need to change this situation, African countries are reforming both continental organization and governance within each state.

At the continental level, the need to accelerate integration led to the creation of the African Union in 2000 and the promotion of the Regional Economic Communities (RECs) as one of the movement's levers, complemented by many initiatives to provide the organization with the principles, structures and means to strengthen its capacity and autonomy to act, until recently under the aegis of President Kagame.

Is Africa succeeding, as it wishes, in speaking with a single voice in the concert of nations, sending a message that is being heard far and wide? The process is in full swing. There is no reason to despair!

All the reports on Africa by the World Bank, UNDP and the Mo Ibrahim Foundation highlight the progress achieved, but also reveal recurring weaknesses: fragility, poverty, unemployment... Many obstacles stand in the way—terrorism, various forms of violence, lack of capital, energy, climate degradation, health and education challenges—all of which require a concerted, sharper focusing of energies to foster more appropriate and innovative responses, such as, for example, the establishment of the G5 Sahel.

Africa is a land of contrasts and contradictions. A few weeks after the African Union launched the Free Trade Area in Niamey, xenophobic violence broke out in South Africa, highlighting, with the closing of borders in West Africa (Nigeria vis-à-vis its neighbours), the difficulties of intra-African migration. This situation parallels the migration of thousands of young

Africans to Europe and their suffering in the Mediterranean.

Aware that each State's internal governance is likely to contribute to peace, the African Union set up the New Partnership for Africa's Development (NEPAD) to clarify its vision and the terms of its relationship with the rest of the world. Its Executive Agency, transformed into the African Union Development Agency, has been tasked with implementing large-scale projects, including infrastructure projects facilitating the movement of people and goods. It has also provided for an African Peer Review Mechanism (APRM) to ensure, through the exchange of good practices, progress in the consolidation of democracy, the rule of law, respect for human rights and the independence of the judiciary.

Good governance within African States is likely to strengthen the continent's influence on the international stage, but many questions arise. Are the piecemeal reforms and the fight against terrorism and corruption underway appropriate? Are they initiated and carried out effectively?

Are civil societies and think tanks playing their role? If so, are policy-makers making use of their findings? What is the impact of the thoughts exchanged at the World Policy Conference?




CHEGRAOUI. Khalid





Thierry de Montbrial is Executive Chairman of the French Institute of International Relations (Ifri), which he founded in 1979. He is Professor Emeritus at the Conservatoire National des Arts et Métiers. In 2008, he launched the World Policy Conference. He has been a member of the Académie des Sciences Morales et Politiques of the Institut de France since 1992, and is a member of a number of foreign Academies. He serves on the board or advisory board of a number of international companies and institutions. Thierry de Montbrial chaired the Department of Economics at the Ecole Polytechnique from 1974 to 1992. He was the first Chairman of the Foundation for Strategic Research (1993-2001). Entrusted with the creation of the Policy Planning Staff (Centre d'Analyse et de Prévision) at the French Ministry of Foreign Affairs, he was its first director (1973-1979). He has authored more than twenty books, several of them translated in various languages, including Action and Reaction in the World System - The Dynamics of Economic and Political Power (UBC Press, Vancouver, Toronto, 2013) and Living in Troubled Times, a New Political Era (World Scientific, 2018). He is a Grand Officer of the Légion d'honneur, Grand Officer of the Ordre National du Mérite. He has been awarded the Order of the Rising Sun - Gold and Silver Star, Japan (2009) and other state honors by the French and several foreign governments. Thierry de Montbrial is a graduate of the Ecole Polytechnique and the Ecole des Mines. and received a Ph.D. in Mathematical Economics from the University of California at Berkeley.

Marrakech

Marrakech est l'une des quatre villes impériales du Maroc. Logée au cœur de la plaine irriguée d'Haouz et au sud du fleuve Tensift, c'est la quatrième ville du pays par sa population, après Casablanca, Rabat et Fès.

Fondée en 1062 par le Roi Youssef Ibn Tachfine, elle fut la capitale du pays sous les dynasties almoravide, almohade et saadienne, dont le règne s'étendait jusqu'à l'Afrique du Nord et l'Andalousie. Le centre historique de la ville, appelé Médina, est classé au patrimoine mondial de l'UNESCO depuis 1985. Construite en terre rouge, la Médina a donné son surnom de « Ville Rouge » à Marrakech. La ville moderne, quant à elle, concentre l'essentiel de son activité économique dans le quartier de Guélia.

Sa situation géographique, au carrefour de la région montagneuse du Haut Atlas et du Sahara, fait de Marrakech une grande place commerçante du pays. Egalement réputée pour la richesse de son patrimoine culturel et ses sports d'hiver, la ville est une capitale touristique incontournable. Elle abrite un aéroport international et est reliée par les voies ferroviaires aux villes de Saf et Casablanca.

Marrakech

Marrakech is one of Morocco's four imperial cities. Located in the heart of the fertile, irrigated Haouz plain and at the south of the Tensift River, it is the fourth largest city in the country by population, after Casablanca, Rabat and Fez.

Founded in 1062 by King Youssef Ibn Tachfine, it was the capital of the country under the Almoravid, Almohad and Saadian dynasties, whose reign then extended to North Africa and Andalusia. The historic center of the city, known as the Medina, was designated a UNESCO World Heritage site since 1985. The Medina's buildings and ramparts are made of red clay, which is why Marrakech is often nicknamed the "red city". The modern city, for its part, concentrates most of its economic activity in the Guéliz district.

Its geographical location, at the crossroads of the High Atlas Mountains and the Sahara, makes Marrakech a major trading center of the country. Also known for its rich cultural heritage and winter sports, the city is a must-see tourist capital. It has an international airport and is connected by railway and road to the cities of Saf and Casablanca.







