Abla Benslimane is the Director of Corporate Affairs in charge of Fiscal and Regulatory issues, Public Relations, and Illicit Trade Prevention for Philip Morris Maroc. Born on July 15, 1974 in Rabat, she studied at American schools of Rabat, Tangier (Morocco), and Bonn (Germany) and later graduated from Al Akhawayn University in Ifrane in 2001 where she majored in International Relations and minored in Women Studies. She later obtained a Masters in Education from Framingham University in 2005. In 2001 she worked with Oxfam Quebec to initiate revenue generating activities for women in the Souss-Massa-Drâa region in southern Morocco and in 2002 she joined the Environment and Development Agency (ENDA) where she participated in the Rio + 10 Project to ensure information flow to French speaking African and Mediterranean civil society stakeholders on sustainable development issues in preparation for the World Summit on Sustainable Development in Johannesburg. She later joined the US Embassy in Rabat as Political Analyst in 2003 where she drafted and contributed to numerous official U.S. government reports and communications, critically evaluated and helped implement policy enhancing projects, and outlined a substantial professional network to keep abreast of societal trends and decision making. During her eight years at the Embassy she also worked with the U.S. State Department Bureau of International Narcotics and Law Enforcement Affairs (INL) to develop specific proposals for improving the Moroccan juvenile justice system in coordination with Moroccan leaders and justice stakeholders. She managed the Middle East Partnership Initiative Women's Pillar for the support and oversight of local reform projects such as Businesswomen's Network, Family Law Advocacy and Awareness. Abla left the U.S. Embassy in 2011 to manage full time her own fair trade business specialized in premium quality Moroccan handicraft products, and in May 15, 2012 she joined Philip Morris Morocco.
